Recent escapes from Loxley Work Release Center cause concerns for local law enforcement

With several recent escapes from the Loxley Work Release Center, local residents and law enforcement officials are questioning the continued use of the facility.

Most recently three inmates escaped from the Loxley Work Release Center over a two-day period.

Damon Rashad Dinsmore, 22, escaped at 2:05 a.m. Monday, July 23, while Catorius Alan White, 21, escaped at 8:05

a.m. Both were recaptured the same day, Dinsmore was recaptured in Atmore, while White was recaptured in Loxley with assistance by the Baldwin County Sheriff's Department.

Cory Allen Kingery, 37, escaped at 6:25 a.m. on Tuesday, July 24 and was recaptured the next day in Jefferson County.

" Oftentimes inmates simply walk off an assigned job and we hear about those later," said Lt. Tony Lovell, chief investigator with the Loxley PD.

"It's the ones that escape from the Work Release Center here that (members of the Loxley Police Department) have to deal with. It just takes a lot of our resources to get them back."

Oftentimes, Lovell said, the inmates have transportation waiting and have left the area. In White's case, he got a ride to the Loxley Motel and was captured after police received a tip.

"Most of these inmates are

Lizzy Hands has left with bruises. She's left bruises on other students. She's been kicked in the head. When there are no female students to spar with, she takes on the boys.

And every hit, every hard knock has made her a more formidable competitor in Yoshukai Karate. This year she has kicked her way to the top, earning a spot on Team USA at the WKC World Championships, an annual martial arts competition attended by athletes from around the world.

The competition will be held this fall in Ireland.

When her friends first towed Hands through the front door of Wheelles Karate, in Gulf Shores, the now eighth grader said she was quiet and struggled sometimes in school.

That was four years ago.

those who are at the end of their sentences, so it's hard to tell why they would take that risk," Lovell said. "A lot of times it is because of family issues."

Both White and Dinsmore were near the beginning of 10-year sentences. Dinsmore was convicted in September 2017 of third-degree burglary; White was convicted in October 2016 for possessing a pistol after being convicted of a violent crime. Kingery was serving a 2-year sentence, convicted in December 2017 of first degree theft of property.

Baldwin County Sheriff Hoss Mack said escapes from the facility do tie up numerous resources for his department and other law enforcement agencies.

"When there are escapes, tremendous amounts of resources get tied up on that where they would normally be doing other routines," Mack said.

Mack said he and other officials have had ongoing talks with the state about the Loxley facility.

"We believe that one of the issues there, based on last week and prior discussions, is that there is a staffing issue there," Mack said. "It seems to fall along

the lines of inadequate staffing on the ground there. We also have some concerns with the facility itself if inmates are able to just walk out of the center and off of the grounds."

Mack said he would continue to reach out to the state to try to find a

solution to the issues but asked the public around that area to stay vigilant.

"We've made our officers be aware to be more diligent, and we ask the public that live in that area that if they see something that looks suspicious, contact authorities," Mack said.

Backyard biosecurity

Backyard poultry flocks are growing in popularity, and for good reason, as there is nothing quite like the taste of a fresh egg laid by a chicken you've raised. But along with the rise in numbers of backyard flocks, there has also been a rise in the number of sicknesses due to Salmonella infections. The link between these two trends has not been definitively proven, but it still presents an opportunity to spread education and awareness on backyard chicken biosecurity.

Biosecurity is just a fancy word meaning "protecting" "life;" including both your life and your birds' lives. Just like with any pet, there are practices that you should adopt in order to have the most rewarding experience with your chickens. We not only need to worry about keeping ourselves healthy when handling chickens, we need to make sure we don't make the chickens sick as well.

With that in mind, the USDA/APHIS and ACES recommend a few simple

steps to prevent diseases in your chickens and yourself.

- **Sanitation:** Chicken feces is the most likely place that a person would contact Salmonella. The feces can be on the ground, in the nesting/roosting areas, on food and water bowls, and on the feathers, beak, and feet of the birds. The number one thing you can do is WASH YOUR HANDS BEFORE AND AFTER touching chickens. Keep the coop area and tools clean, as well as the clothing and shoes that you wear when tending to the flock. It's best to have a pair of shoes dedicated to "chicken work." You could also wear protective coverings over your shoes or set up a foot-wash station that is utilized when entering and exiting the coop area. Whatever you do, don't wear shoes that have been worn in the chicken's area inside

your home until they have been thoroughly sanitized. Sanitation also prevents YOU from spreading germs to your chickens.

- **Isolation:** keep your chickens away from other pets, especially other poultry, and protect their area from wild birds as much as possible. If visitors are curious about your chickens, but have chickens of their own, it's best if they do not come in direct contact with your flock. Chicken swaps, flea markets, and other places where poultry from different places are gathered is prime opportunity to spread disease between flocks. Try to avoid these situations as much as possible.

- **Knowledge:** Know your birds! Spend enough time familiarizing yourself with your flock so that you will recognize any unusual behavior. Signs of sickness should be treated immediately with medication and quarantine if necessary. If you find a dead chicken or wild bird nearby, assume that it has a contagious disease and dispose of it immediately and properly.

Brigid McCrea, Extension 4-H Animal Specialist, reminds people with backyard chickens to "wash hands and do not kiss chicks or chickens."

BOLO for Fall Armyworms
Regional Extension

Agent Kelly Palmer warns producers that now is the time to scout for Fall Armyworms. Treatable populations in Alabama have been reported in the last two weeks in Clarke, Marengo, and Butler Counties; and new reports continue to come in each day.

Monitoring Tips:

1. Use a sweep net to monitor once a week.
2. Start at the edges of the field, as fall armyworms tend to migrate into fields from surrounding areas.
3. Fall armyworms are most active in the early morning / late afternoon, so take samples during these times to get a true sense of infestation level.

We often hear, "these armyworms appeared overnight and they ate everything!" Fall armyworms feed in their larval stages (caterpillars) for approximately 14 days. The first 10 days, they don't eat very much and can go unnoticed in fields. The last 4 days, the final (and largest) larval instar, consumes the most forage. For this reason, monitoring with a sweep net weekly is essential!

Fall Armyworms can also be pests of home lawns, so it's important to keep scout your grass as well.

Now, at Wheelers Karate she memorizes lengthy forms — a series of detailed movements that include stepping, turning and jabbing while maintaining perfect posture and form.

She counts and recites many phrases in Japanese.

And to earn her 1st degree black belt last October Hands faced a three-hour skills test, a four-page written test, a quiz on basic Japanese and a one-mile run.

“It’s a challenge, I love it,” she said.

Hands spends up to six hours a week at Wheelers and additional hours at home working out. The discipline required for the sport has not just earned her a black belt, but has helped her excel in school too.

“Memorizing all the

moves, the discipline, it’s all helped her improve her memory and her school work,” said her dad Michael Hands.

Hands travels to nearly a dozen competitions in the southeast each year. This year she nabbed first and second in her individual events at the regional competition in New Orleans and second place in sparring at the national competition in Michigan. That win earned her a place on the team heading to the international competition in Ireland this fall.

She is the first competitor from Alabama to

earn a spot on the team.

To prepare for the larger stage, Hands is studying other competitor’s tactics. Her favorite move, the round kick, is also her secret weapon. The 13-year-old can throw her leg as high as many competitors’ heads.

Her instructor, Chris Wheelers, said as students overcome the difficulty of the sport they realize their full potential.

“The stuff they overcome in here makes them realize they can do anything,” he said. “She has gained so much

transplant. They really don’t go into any detail. It’s TV, after all. However, all of a sudden, organ transplants have become a focus to many in Baldwin County, specifically with the need of a kidney by the Pastor of Our Lady of the Gulf Catholic Church, Rev. David Carucci. Father Carucci has served the Mobile Archdiocese for

23 years, serving at St. Bede as an associate and later as pastor and also as pastor at Little Flower in Mobile, St. Thomas-by-the-Sea in Orange Beach and Saint John the Baptist and Our Lady Queen of Mercy in Montgomery. Even before he became ordained, he was a teacher at Montgomery Catholic, another way of service. He suffers from a condition known as IgA nephropathy, occurring when an antibody called immunoglobulin

A (IgA) lodges in the kidneys. It is also known as Berger’s Disease. Because his father also had the disease, Father Carucci’s family members, who would normally be the logical donors, are not eligible to donate. Now what? Here is a man who has donated his life to serve others as a Catholic priest. He has been on dialysis for 15 months, he needs a kidney and where can he get one? Time is running out. Never let it be said

that a good Christian lets a good man down, so his friends rallied to the cause and are sending out an urgent plea, first for prayers and second for a kidney. Long-time friend Kay Trattles was one of the first to volunteer, but after a variety of tests at the University of Alabama (UAB) Medical Center, she is not eligible as a donor for Father Carucci or as a donor pair. She didn’t let it go, though, as she volunteered to be Father Carucci’s advocate, to inform the public, to get this priest the life-saving help he needs. An interview has been arranged with UAB on Catholic radio, Archangel Radio, 1410AM, from 7 to 8 a.m. on Monday, Aug. 6. During this time those who are interested in donating a kidney to Father will hear all about the

process. There are three ways to acquire a kidney, from a deceased donor, a live donor and donor pairs. There is a long list of those waiting for a kidney from a deceased donor and the pool is diminished, so we move on to live donors. Kidney transplants from live donors have a 98% rate of success. Other than a blood relative, this may be a biologically unrelated person who has a connection with the transplant candidate, such as a spouse or significant other, a friend, or a coworker. A person who has heard about the transplant candidate’s need may also volunteer. Those who want to give a kidney to Father Carucci only, may begin the testing locally. The Kidney Paired Donation (KPD) helps those who are either recipients or

donors. Here’s how it works. Donor #1 can’t give a kidney to Recipient #1 due to blood or tissue incompatibility, but he or she might be able to give it to Recipient #2 who is compatible. Perhaps someone in the family or friends of Recipient #2 is not compatible, but would be with Recipient #1. Recipient #1 would receive the kidney from Donor #2 and Recipient #2 could receive the kidney from Donor #1. There are numerous ways these donors may be paired. UAB uses a KPD database to identify possible donors to pair. If a match is favorable, the physicians, transplant surgeons and program staff move on to the next phases. In a KPD, the tests are performed at UAB. When matches are found, all are notified and potential donors and recipients are evaluated with blood work, CT scan, urinalysis, EKG, chest X-ray and a visit with a social worker. If all goes well, the donation surgeries and transplant are scheduled to occur at the same time. Medical expenses will be covered under Father Carucci’s carrier. Great Lakes, and Australia.

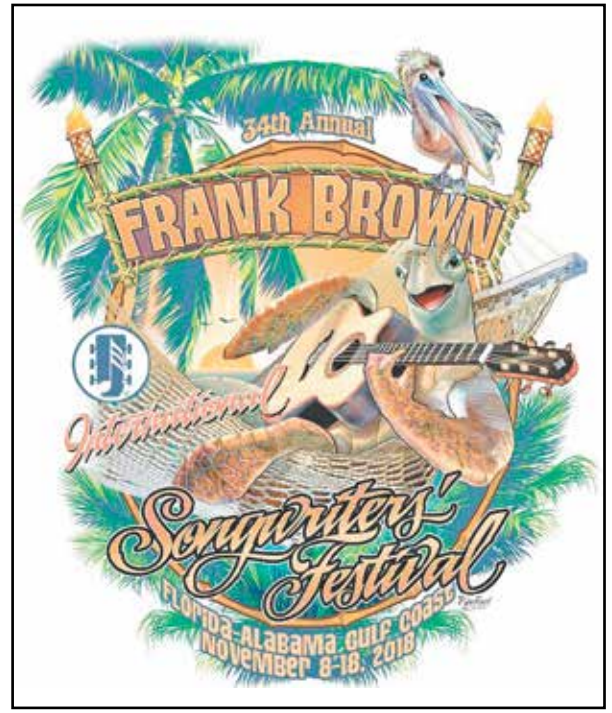

Byrne celebrates passage of Career-Technical Education Bill

Washington, D.C. — Congressman Bradley Byrne (R-AL), a member of the House Education and the Workforce Committee, today celebrated passage of a landmark career and technical education (CTE) reform bill.

H.R. 2353, the Strengthening Career and Technical Education for the 21st Century Act, makes reforms to the Carl D. Perkins Career and Technical Education Act to ensure more Americans enter the workforce with the

skills they need to find a good-paying job in an in-demand skill area.

Congressman Byrne said: "This bill won't get nearly the attention it deserves, but this is a huge, bipartisan victory for students, businesses of all sizes, and the American people. By improving our nation's career and technical education programs, we can better meet the demands and realities of the 21st Century economy and put more Americans to work."

The bill passed out

of the House on a voice vote. Since the bill passed the Senate earlier that week, it went to President Trump for his signature, and he signed this week.

Congressman Byrne said: "Mr. Speaker, we have a skills crisis in our country. We actually have more job openings than we have unemployed Americans. This is keeping our economy from reaching full potential.

"So how we do solve this problem? Well, a big way is through

expanding career and technical education programs. As the demands of the workforce continue to change and become more complex, these programs are critical to building the workforce of the 21st Century.

"I've seen these programs firsthand back

in Alabama, in our high schools and I saw it work in our two-year colleges. They benefit the local economy by helping fill open jobs, but they make the lives of our students intrinsically better by connecting them with the skills they need to thrive.

"So, I urge my col-

leagues to support this bill and show the strong, bipartisan support that we showed when it passed the House the first time. Career and technical education is for everybody in America, and America's House needs to stand up and support it."

Stop for school buses

School buses will be back on the roads in just a few days. Not sure if you have to stop? Review the rules. Hefty fines can start at \$300 for the first offense and can result in license suspension and eventually a Class C felony charge for a fourth offense.

Under Alabama law it is illegal to pass a stopped school bus or church bus on any road, regardless of how many lanes the road is.

The only exception: drivers on a divided highway (at least four lanes wide) with a median physically separating the two sides and traveling the opposite direction of the bus do not have to stop.

If you are on a divided highway and traveling the same direction of the bus you must stop.

Traffic laws

TWO-LANE ROADWAY: When school bus stops for passengers, all traffic from both directions must stop.

FOUR-LANE ROADWAY WITHOUT A MEDIAN SEPARATION: When school bus stops for passengers, all traffic from both directions must stop.

ROADWAY OF FOUR LANES OR MORE WITH A CENTER TURNING LANE: When school bus stops for passengers, all traffic from both directions must stop.

TWO-LANE ROADWAY WITH A CENTER TURNING LANE: When school bus stops for passengers, all traffic from both directions must stop.

Back to school immunization clinics in August

Parents are offered the opportunity to vaccinate their children for school at the Baldwin County Health Department. The health department has set aside special dates for the Immunization Clinic: Aug. 3, 6 – 8 and 13 – 14.

Walk in availability will be open from 8 a.m. until 4 p.m. The clinic is located at 23280 Gilbert Drive in Robertsedale. Parents are asked to bring any documentation of the child's vaccination history as well as insurance information, Medicaid or BCBS. There will be a

maximum charge of \$ 15.

Requirements for school attendance are listed below.

- Children entering school in the fall are required by Alabama Law to present a Certificate of Immunization formerly known as a "Blue Card".

If a child has received all required vaccines and only needs a Certificate of Immunization, these can be printed and issued from that child's school. Proof of vaccines received out of state will need to be brought to the health department where they will be entered into the Alabama

system and families will be issued a blue card.

- Children entering Kindergarten need boosters of DTaP, Polio, MMR and Varicella. These shots complete the childhood series for Diphtheria, Tetanus, Pertussis, Polio, Measles, Mumps and Rubella.
- Children age 11 and entering the 6th grade need a Tdap vaccination.

If you are unsure whether your child needs shots, check with your pediatric provider or the Baldwin County Health Department at 251-947-1910.

GSST swimmers compete at Southeastern Swimming Long Course Championships

GULF SHORES — Layne Reid, Jack Biggs, and Murray Reed represented the Gulf Shores Swim Team at the Southeastern Swimming Long Course Championships on July 20-22. The meet was held at the University of Tennessee in Knoxville. There were 45 teams with over 1,000 swimmers entered in the meet from the region. The Southeastern Swimming region is Alabama, Tennessee and the Florida Panhandle.

The three Gulf Shores swimmers qualified for this meet by virtue of their results in previous long course meets during this spring and summer season.

Reed and Biggs swam in the 10 and Under Boys division at the championship meet. Reid represented the Gulf Shores Dolphins in the 11-12 Boys division.

Reed, age 10, swam in six events and set six new Gulf Shores Swim Team records in the 200, 100, and 50-meter Free-

styles, 50 Breaststroke, 100 Breaststroke, and 50-meter Butterfly for his age group. Reed scored 97 points for the team and finished in third place for high-point recognition in his age group.

Reed won the 50 and 100-meter Freestyles. He placed second in the 200-meter Freestyle. He also placed fourth and sixth in the Breaststroke races and captured seventh in the 50-meter Butterfly event. He was compet-

ing against 45 or more swimmers in his division in each event including his teammate, Biggs.

Biggs, age 9, also competed in six events during the three-day swim meet. He set personal best times in five of the events. His highest placing at the meet was 12th in the 50-meter Freestyle, where he lowered his time by 2.56 seconds.

Reid returned to the long course championship meet as an 11-year-old. He qualified and

swam the 50-meter breaststroke in the 11-12 division. He finished near his qualifying time and gained valuable experience at the next

The humble golf cart

Golf Today

Golf carts by definition are a small self-propelled vehicle designed to carry two people around a golf course with less effort than walking.

The idea, and first use of a golf cart is credited to J.K. Wadley, a resident of Texarkana, Texas/Arkansas, who in 1932 after witnessing a senior citizen using a three-wheel vehicle to get to the grocery store, decided it would be perfect on his local links, it wasn't.

For the next 20 years the cart continued to be used mainly for people with disabilities. It wasn't until the 1950s that golfers figured out that they could carry an extra cooler of adult beverages and have a safe place to put their cigars while they hit the next shot, golf carts time had finally come.

The Marketeer Company started producing the vehicles in 1951, EZGO in 1954, and other notable companies like Victor Adding Machines, and Sears and Roebuck produced carts, mainly electric. In 1957 Max Walker invented the first gasoline powered golf cart called the "Walker Executive" It was a trike with a Vespa style front end and carried two passengers and bags.

Golf carts have become popular and are used for much more than chasing the little white ball. Peachtree City, Georgia, has miles of cart paths that link the city together. McIntosh High School has a student golf cart parking lot on campus.

On Belize, golf carts are a major mode of transportation, and are a popular tourist rental. They've also become favorites at hunting camps, factories, and yuppie neighborhoods where residents drive carts tagged NEVs, or neighborhood electric vehicles.

Not surprisingly age limits do apply when it comes to taking the wheel. In Alabama, Georgia, California, Iowa, Kansas, Kentucky, Rhode Island, and Vermont minimum age is 13. Florida is 14, and the rest of the country is 15.

Most golf carts are powered by gas or electric, but now even solar is available. The strangest new design is linked to our own Master's champion Bubba Watson. For a mere \$58,000 you can purchase an Oakley BW1 Golf Cart Hovercraft. You can glide across the golf course without a mark, and even hover over the lake to look for a lost ball. It comes with a 65-hp Hirth engine that can push two golfers, and a caddie up to 45 mph in quiet comfort.

Sports Federation for Disabilities.

The Adaptive Sports program is a unique course of advanced study designed for coaches who have or want to have experience working with athletes with varying degrees of adaptive needs. The program has a two-pronged approach that includes working with competitive athletes and developing inclusive programs for recreational athletes.

Floyd has more than 40 years of experience in the sport, education, training, leadership, instructional design and management fields.

“Teaching in Bahrain has been a truly exciting and rewarding experience,” Floyd said. “Being a part of the Bahrain Training Project for Disability Specialists through the United States Sports Academy is the highlight of my 40-year career as an educator, coach, and administrator.”

“The students embraced the coaching skills and disability sports with excitement, new shared visions, and a new outlook toward the disabled — from seeing the disability



to seeing the ability. Their immersion into Paralympic Sports by actively participating in the sports has deepened their understanding of both the skillsets needed in coaching and by learning how to remove the barriers and obstacles so that everyone can participate in sports and recreation.”

Floyd, who has worked in athletic and education administration since 1980, taught courses related to sports coaching methodology, adaptive athletics and sports, inclusive recreation services, and nutrition and ergonomic aids.

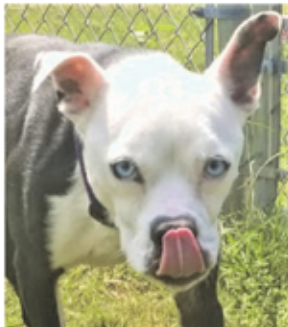

Because of some of their overnight shifts, I've gotten used to questions about cat surgical procedures or obscure dog bowel diseases popping up on my phone at 2 a.m.

Some time ago, a conversation about problematic pet owners was set off when one of my friends complained that a client brought in their dog for being itchy.

While this seems like a fairly common issue for dogs, the follow-up is where it completely derails as she wrote, "They think it's because there are ghosts in their apartment."

Clearly, the most logical answer to the problem.

This started a deluge from the other vets in the group.

There was the client who thought a serial killer had tortured her cat by tearing its ACL.

A schizophrenic cat lady who thought her precious pet was possessed by a demon and the government was using the microchip inside the cat to listen to her thoughts was quickly asked to sign the cat over to the vet office so they could find it another, less insane home.

One patient asked for help over the phone in getting their dog motivated. When questioned further, apparently the dog had been lying around the backyard for days and hadn't moved from the same spot - nor was it breathing.

In my job, I get to interact with the public a good bit, but even I get nowhere near the level of crazy that my Vet Gals do.

So, in the spirit of having some of you dear readers not end up as crazy stories your vets tell to their friends, let me give you some helpful words of advice:

- Garlic does not "ward off fleas," despite whatever natural animal medicine blog you read it on. It's actually toxic to pets and can kill them.

- "Watering your lawn correctly" is also not a form of flea prevention.

- Heartworms cannot be prevented by you "having a fenced-in yard and living in a nice neighborhood." Heartworms are also not stopped by "living in a gated community."

- A tablespoon of Guinness beer per week is not a heartworm cure. (I was saddened to find this out as well; apparently, I'm still at risk for heartworms despite by best efforts to self-medicate — though I did exceed the supposed recommended dosage by a few tablespoons.)

- Rubbing a whole orange on your pet will not cure fleas.

- Essential oils (lavender, lemon, rose) do not cure fleas either. Stop believing everything you read on the Internet.

State must do better at Loxley Work Release Center

In light of three recent escapes from the Loxley Work Release Center in the last two weeks, local residents and law enforcement officials have many questions about how inmates continue to escape from the facility and what is being done to prevent them from happening again.

Unfortunately, the state has not yet answered.

When a work release facility is so close to both a major thoroughfare (County Road 64) and a residential area home to families with young children, answers and swift action from the state are necessary now.

The state should be doing a better job of reviewing which inmates are allowed at the facility. For example, one of the recent escapees, Catorius White, had previously been convicted of a violent crime. Violent criminal offenders should never even be allowed to enter a work release facility.

In our interview with him, Baldwin County Sheriff Hoss Mack said he believes the issues at the Loxley facility stem from inadequate staffing on the ground there. He said there are also concerns about the facility's security itself if inmates are

able to just walk out and escape.

It is no secret that Alabama's prison systems are overcrowded and underfunded. We continue to hear Montgomery say they're going to fix it.

However, when a work release facility like this is part of our community and inmates keep escaping and committing crimes, action needs to be taken immediately.

Thankfully, no physical harm has come to a local resident or law enforcement officer from an escaped inmate yet, but that could only be a matter of time unless the state takes action.

Montgomery: fix the issues with the Loxley facility or close it down.

The safety and security of our county is too precious to ignore.

More analysis of GOP runoff

Currently, congressmen/women win reelection at a 98 percent rate. The communist politburo does not have that high of a reelection percentage. Maybe we have more in common with the Russians than Washington CNN reporters think.

It is hard to get beat as an incumbent congressman. Martha Roby tried but even though she was the most vulnerable Republican incumbent congressperson in the country, she shellacked a former Montgomery mayor, one term congressman, and doggone good country one-on-one politician Bobby Bright. She beat him like a rented mule, 68-32.

It was assumed that whoever ran against her in this year's GOP Primary would beat her. She was scorned and mocked in her district and even uninvited to GOP events. Indeed, four viable men ran against her in the GOP Primary. She outspent them four-to-one and still only got 39 percent to Bright's 27 percent.

She pulled it out in the runoff for two reasons. Donald Trump endorsed her, which was manna from heaven. The Agriculture race ended about as expected in the runoff. Rick Pate led Gerald Dial 40-to-30 in the first primary. Pate beat Dial 57-to-43 in the runoff.

Pate is a lifetime farmer and longtime Farmers Federation leader. The Alfa endorsement was critical in this race. They loyally supported him. Pate won even in the metropolitan counties. Alabamians inexplicably have a way of picking the farmer in this race.

The turnout in the GOP runoff was abysmal. It was around 12 percent statewide. However, in counties where there were local races, it was between 25-35 percent. All politics is local. Walker County had 25 percent turnout because they had a tough sheriff race. Marion had three local runoff races and voted at 28 percent. Marshall County had two local candidates running statewide, Will Ainsworth and Steve Marshall. They voted 19 percent.

In Alabama political history, Barbour County has been known as the Home of Governors, and indeed, six Alabama Governors have called Barbour County home. In the 80's and 90's Cullman County claimed two Governors, Guy Hunt and Jim Folsom, Jr. Of course, little Jim's daddy, Big Jim, was governor in the 1940's and 50's. That gave Cullman County three governors. Tuscaloosa has had three governors. They should rightfully claim Lurleen Wallace, who was born and raised in Northport. Only a few years ago, Tuscaloosa had a unique advantage of claiming the Governor Robert Bentley and Alabama's Senior Senator and most powerful politico, Richard Shelby, at the same time.

However, the results of the Republican Primary have propelled Marshall County into the limelight. Beginning with the next quadrennium, Marshall County will more than likely lay claim to both Lt. Governor Will Ainsworth and Attorney General Steve Marshall.

For generations the legendary Beat 14 in Elmore County was the Bellweather box in the state for predicting the governor's race and mirroring the results statewide. In recent years their clairvoyance has diminished. There is a new rival to Beat 14 in Elmore County, Patsburg in Crenshaw County has been getting it right for a while now. In the July 17 runoff, Patsburg got every race correct. As Patsburg goes, so goes the state.
